SEPA RETURNS TO ORLANDO FOR 2002

For the first time since 1986, SEPA returns to Orlando, Florida for its annual meeting, March 21-24, 2002. The meeting will be held at the Hyatt Orlando resort hotel, near the Disney World area. With Florida having the highest concentration of older adults in the United States (nearly 50% more than the national average), and given the increased importance of aging issues in our society, the theme for this year's meeting is ASEPA Comes of Age: Psychology and the Aging Revolution (with special acknowledgment to APA for the subtitle based on their recently published book).

This is the first time that there has been a specific emphasis on aging issues for the annual meeting, although program submissions, as in the past, may cover any area. This year, the invited speakers will all be nationally renowned Ageropsychologists specializing in the application of their psychology sub-discipline to many different issues in aging. We are fortunate that much of the nationally recognized research on the psychology of aging is taking place within the SEPA region, and we look forward to drawing from that rich pool of talent, as well as other national speakers.

► The Siegel/Wallston Invited Lecture will be delivered by Harvey Sterns, Professor of Psychology, and Director, Institute on Lifespan Development, University of Akron. Dr. Sterns directs the only Ph.D. program in the U.S. in Aindustrial gerontology, the application of principles of industrial and organizational psychology to such issues as older workers and older consumers.

► The Rosecrans Invited Lecturer will be William Haley, Chair, Department of Gerontology, University of South Florida. Dr. Haley will address issues

in Aclinical geropsychology, both in his role as President, Section II, Division 12, Clinical Geropsychology, and as an internationally renowned researcher on caregiver issues.

► Wendy Rogers, School of Psychology, Georgia Tech, will present an invited lecture on Human Factors and Aging, with an emphasis on her innovative research with the latest AComputer House technology.

► An Invited Lecture will be delivered by Susan Krause Whitbourne, Professor of Psychology, University of Massachusetts. Dr. Whitbourne is a master teacher in the psychology of aging, and in addition to her distinguished record of research, has recently authored or co-authored several major texts on aging.

In addition to these invited addresses, there will be the annual Psi Chi/SEPA invited address. This year's speaker will be Florence Denmark, a past-president of APA and Professor Emeritus at Pace University, who is currently researching women's issues in aging. More details on other events being planned to utilize the unique attractions in the Orlando area will be forthcoming in the ACall for Papers to be mailed out at the end of August.

UCF Welcomes SEPA to Orlando in 2002!

On behalf of the Department of Psychology at the University of Central Florida, home of SEPA President elect, Dick Tucker, and the entire Orlando-Central Florida Community, I would like to extend a warm welcome to those who plan to attend SEPA 2002 in Orlando, Florida.

The area where the convention will be held provides easy access to the Orlando International Airport, downtown Orlando, theme parks such as the Magic Kingdom, Epcot, MGM Studios, Islands of Adventure, Universal, and Sea World, and the world famous beaches at Cocoa Beach and Daytona.

Everyone is aware that Central Florida is the tourism capital of the world but you may not be aware that Orlando was recently ranked 10th among the top 50 largest metropolitan areas in the country not only on the basis of its well known tourism, but also because of its growing and diverse high technology industries.

I remember with great pleasure my first SEPA, in the spring of 1973, when I presented a symposium on confidentiality in psychotherapy. After joining the faculty at UCF in the fall of 1972, I have missed SEPA only once since that initial meeting.

The University of Central Florida, located about fifteen miles east of downtown Orlando (also with campuses at Cocoa and Daytona Beach), has been a strong supporter and participant at SEPA since UCF first began offering classes in the Fall of 1968 to about 1500 undergraduates. UCF enters the 2001-2002 year with approximately 35,000 students representing 76 baccalaureate programs, 56 masters and 18 doctoral programs. The Department of Psychology, with over 1800 psychology majors, includes 2 baccalaureate and 5 graduate programs.

We know that SEPA 2002 will be an outstanding meeting and we look forward to seeing all of you here in beautiful Orlando. So, get your symposia, panels, posters and papers ready, be on the look-out for the SEPA call for papers in early fall, and bring your families to enjoy SEPA 2002-Orlando.

James L. Pate

The SEPA History Project, under the direction of James L. Pate, has several major components. The first component, and in many ways the most important, is the collection of archival materials. The archival collection includes official documents or publications about the association, and many items that may be relevant to the activities of the association or to its history.

The SEPA History Project includes an annual symposium on the history of psychology departments in the southeast. In most years, histories of a department that grants the doctoral degree, a department at a liberal arts college, a department at an historically Black college or university, and the current SEPA president's department are included in the symposium. If you are interested in participating in this symposium or you simply want to write a history of your department, contact me and I will provide additional information.

A second symposium is organized for the presentation of papers about the history of psychological research in the southeast. In the past, this symposium has included the history of clinical psychology, and social psychology, psychometrics, verbal learning and memory, and non-human language. Although the emphasis is on activities in the southeast, information from other regions of the country or world may be included in the papers.

A third symposium was added to the SEPA History Project for the 2001 meeting. In 1992, Dr. Harold Moon began a symposium series on eminent southeastern women psychologists, and Dr. Jane Ellis assumed responsibility for organizing the symposium in 1997. For the 2001 meeting, Dr. Ellis and I organized the symposium. For the 2002 meeting, Dr. Sabina Widner and I will organize the symposium, which has been expanded in scope to include any psychologist in the southeast. If you wish to nominate a person about whom a paper might be presented or if you would like to present a paper, please contact me.

The final component of the project is the annual historian's lecture. If you would like to hear about any aspect of SEPA, you may recommend a topic to me. I welcome your participation in, and suggestions about, any of the SEPA History Project components. A New Day For CEPO

The spring 2001 SEPA convention in Atlanta was a success, and we're looking ahead to making the Orlando convention even better in 2002. The CEPO speakers did a great job, and sessions were well attended. Keynote speaker, Dr. Bertha Holiday, APA Director of Ethnic Minority Affairs, delivered a rousing message on the importance of all women working together to achieve the goals laid out by feminist psychologists, during the founding of CEPO. She also provided statistical information to document the feminization of psychology, the reasons for it, and strategies for increasing the number of minority males and females who complete masters and doctoral degrees in psychology.

Another key speaker, Dr. Ruth Greene of Johnson C. Smith University, presented timely information on how to obtain government grants to fund campus projects, including funding for release time, travel, student workers and writing activities related to psychological research. If you missed this information, you may contact Dr. Greene at Johnson C. Smith University.

In addition to exemplary speakers, fundraising efforts to support the publication of the student abstract souvenir booklets went extremely well. Drs. Pamela Scott-Johnson, Angela Farris-Watkins and the Spelman College Psychology Department deserve gratitude for making the continuation of the booklets a reality.

As I complete my term as CEPO chair, I want to let you know of some of the new directions for CEPO. The Visiting Scholars Program was developed to highlight research by and about members of under represented groups during a time when other opportunities were quite limited. Given today's circumstances, it was suggested that CEPO's goals could now be better met by programming directed at a larger audience.

Therefore, funds have been moved to support an additional invited convention speaker who will address issues of inclusion. President-elect and Program Chair Richard Tucker will consult with the CEPO chair to select a speaker whose address will complement the 2002 conference theme of aging. As Program Chair, the President-elect selects the invited speakers and the program theme, and all funding for convention speakers has traditionally come from the Program budget.

Another change taking place within CEPO will be our increased attention to the broad CEPO mission of equality in professional and research opportunities, specifically including older and impaired psychologists as we as men of color.

Additional goals we hope to achieve in coming years are to obtain a voting position on the SEPA Executive Committee for the CEPO Chair and to provide funding for the expenses of our invited keynote speakers at the convention.

I leave these tasks and any others that may arise in the capable hands of incoming chair, Dr. Harriette Richard of North Georgia College and State University. Dr. Richard was unanimously elected as CEPO chair for 2001-2003. Dr. Sekai Turner, of the University of Pittsburgh, will also be joining our staff to assist Dr. Rosemary Phelps, University of Georgia, in the Minority Interest Group. All other CEPO co-chairs will continue their present roles.

I look forward to continuing to work for and with CEPO. Thanks to all of you for support during my time as CEPO chair.

Outstanding Professional Presentation Awards

The first SEPA/APA Outstanding Professional Presentation Awards were announced at the 47th Annual Meeting in Atlanta. The awards are funded by a grant from APA's Science Directorate and are intended to encourage the oral presentation of high quality psychological science by our professional members.

Nine finalists were selected based on initial abstract reviews, and a special panel of judges subsequently read the completed manuscripts and listened to the conference presentations. This year's award recipients were:

First Place (\$500)

Korrel Kanoy, Peace College, Marital relationships and hostility factors that predict physical punishment of children. Her coauthors were Beril Ulka-Steiner, Martha Cox, and Margaret Burchinal.

Second Place (\$300)

John N. Bohannon, III, Butler University, The effects of input source group on flashbulb memories. His coauthors were Victoria S. Cross, Erin J. Roth, Sarah Raynor, and Kathy Kurek.

Third Place (\$200)

Janie H. Wilson, Georgia Southern University, Play reduces rat prolactin: Stress reduction in the open field.

Special thanks are due to our panel of reviewers: Judith W. Rhue, Ohio University; Donald E. Jackson, Eastern Michigan University; Karen Brakke, Spelman College; John E. Williams, Georgia State University; Scott Duncan, U.S. Justice Department; and Harold Moon, Augusta State University.

SEPA Seeks New Administrative Officer

Dr. Frances Dunham, SEPA's Administrative Officer, has notified our Executive Committee of her desire to retire from that position. It would be desirable to choose her successor so that this person could apprentice to Dr. Dunham beginning with our 2002 meeting in Orlando. Last year President Sheila Eyberg asked me to coordinate the search for a new Administrative Officer. As we all know, the AO and the office (s)he directs are the key to a smoothly running organization and annual meeting.

The AO occupies a staff (not a policy-making) position, implementing policies of the elected Executive Committee. Major duties fall into three areas: administering the process of preparation of the Convention program, organizing the details of the annual Convention, and conducting the ongoing communication and financial activities of the Administrative Office. The position is currently structured as a part-time position (one-quarter to one-third time) and carries an administrative stipend (around \$12-\$14,000). It requires a few hours per week year-round, with greatly increased demands in November, December, and March in relation to the preparation of the program and management of the Convention.

We believe that important prerequisites for this job include:

- . willingness and ability to serve as an implementer and catalyst.
- . negotiation and other interpersonal skills to deal successfully with the membership, representatives of hotels, vendors, and other organizations, and the public.
- . attentiveness to detail, for example in scheduling and bookkeeping, and ability to see how details fit together.
- . competence or ability to develop competence in use of microcomputer programs for membership and financial records.
- . successful experience in administration, including supervision of staff and development and management of budgets.
- . affiliation with a work setting that will provide SEPA with free suitable office space.
- . SEPA member, familiar with the role of the regional organization in psychology.

Current or prior service on the SEPA Executive Committee would be a desirable qualification because of the understanding of SEPA operations and the institutional memory that such service would normally develop.

Please help us identify strong candidates for this important position. Perhaps you yourself are prepared and interested in applying. If not, please consider whether someone you know would be a good candidate for SEPA's Administrative Officer.

To be considered for the position of Administrative Officer, one should prepare a narrative addressing qualifications in terms of the information provided above. Strong applications will include examples of work and accomplishments pertinent to the major duties of the position.

In addition, they will describe potential arrangements for suitable office space. We ask that candidates send names and contact information for at least two persons familiar with their experience and suitability for this position. Finally, the applicant needs to include a formal offer from the potential host site of the support they will provide to SEPA should that person be chosen. This material should be sent to:

To ensure full consideration, this information should be received by September 15, 2001. This will allow time for applications and other information to be reviewed by the Executive Committee so that a selection can be made in time for the person to begin apprenticing in March of 2002.
